2. By registering for this challenge you are pledging to raise a minimum of £100 and understand that it is the endeavour of this challenge to raise as much above the minimum amount as possible in aid of the Children's Adventure Farm Trust.
3. You must send all of your sponsorship (minimum £100) to CAFT no later than 4 weeks after the event has taken place.
4. If you have to cancel your place, you must notify Jure at CAFT as soon as possible.
5. CAFT or the organiser may at their sole discretion, withdraw a participant before or during the challenge.
6. The organiser NOVA International specialises in challenges of this nature and is solely responsible for organising and running the event including the safety of participants.
